


- Port Infrastructure Development Program (PIDP)
  - Started in 2019 for projects that "improve safety, efficiency, or reliability of the movement of goods into, out of, around, or within a port." Commercial fishing included.
  - 25% reserved for "small projects at small ports"



U.S. Department of Transportation Maritime Administration (MARAD)

- Established to "foster, promote and develop the maritime industry..."
- ~800 employees, most in Washington DC; gateway offices (Seattle)
- For PIDP, we interact with regional contacts, grant managers, engineers, environmental compliance, counsel


- Hot Tip #1: MARAD does not want to fund temporary infrastructure
  - MARAD staff easy to work with, very responsive
  - MARAD wants to get you your awarded funds
  - Early calls/site visits to discuss the project description



### **Prior to Release of Funds Grant Agreement**

- Create early strategy to:
  - Execute grant agreement quickly
  - Maintain grant compliance
  - Obtain pre-award approval (i.e., early fieldwork)
- Hot Tip #2: Grant compliance can take time, plan accordingly
  - Scope, schedule, budget considerations
  - May need to front costs until reimbursement allowed



- National Environmental Policy Act (NEPA)
  - Required for actions with federal nexus, includes federal funds
  - Is a process, not a permit
  - Provides environmental consideration
    for decisions
  - Allows for public input
  - Can be adopted, combined with SEPA, SEPA can support NEPA
  - NEPA guidelines vary




#### Categorical Exclusion (CE), 2-3 mo.

• Actions that individually or cumulatively have no significant effect on the human environment

#### Environmental Assessment (EA), 6-12 mo.

- Actions for which significance of impacts are uncertain and require further review
- Environmental Impact Statement (EIS), 12-24 mo.
  - Actions that have been determined to have significant environmental impact

Hot Tip #3: MARAD

 Hot Tip #4: Do not piecemeal, do not unnecessarily federalize


- Hot Tip #5: NHPA Section 106 and ESA Section 7 must be completed before MARAD will review NEPA document

### **Post-Release of Funds Bidding, Federal Procurement**

- Hot Tip #8: NEPA must be completed before bidding, procurement, construction
- Hot Tip #9: Grant agreement must be signed before construction Notice To Proceed (NTP)
