#### WPPA President's Corner

We are only about a week away from Interim Executive Director Patsy Martin joining our WPPA team on June, 1, 2022. For those of you who may not be familiar with the former Executive Director of the Port of Skagit, Patsy Martin began her career at the Port of Anacortes before coming to the Port of Skagit as the Property/Development Manager.

She worked at the Port of Skagit for nearly three decades, 14 years as an Executive Director. According to the Port of Skagit, Patsy's "...dedication to the Port of Skagit's mission of 'Good Jobs for the Skagit Valley' is punctuated by a long list of accomplishments and accolades that include the creation of an innovative wetland protection program, the expansion of buildings, public assets and funding partnerships to support Bayview Business Park, Skagit Regional Airport and La Conner Marina, the development of the 10+ miles of nature trails through the Port, investing in critical infrastructure to support the value-added agriculture sector, the acquisition of the Northern State Hospital property and the statewide distinction as Port of the Year by the Washington Public Ports Association in 2018 to name a few. More broadly, Patsy has led collaborative efforts to increase the effectiveness of ports through her strategic planning, relationship building, and leadership within partnering organizations." Patsy was awarded a lifetime membership by WPPA in 2020 for her dedication to the port community. I hope you are as excited as I am about welcoming Patsy to the team.



As for a permanent Executive Director for the Association, the Executive Committee has narrowed down the headhunter firms to two possibilities, one of which will be offered a contract within the next week. Patsy will chair the search for the next Executive Director and will extend personal invitations to members to join the search committee when she arrives in early June.

I'm also excited to share that Port of Tacoma Commissioner Don Meyer has joined the Executive Committee as an Ex-Officio member. Historically, the Ports of Seattle and Tacoma have had Ex-Officio members on the Executive Committee, but not for the past couple of years. Commissioner Meyer, as you may recall, was WPPA President in 2019; he has a lot of relevant and recent experience to bring to this position.

We had 30 completed responses to our Spring Meeting survey, in which we asked a variety of questions related to satisfaction about our venue, registration, receptions, educational content, and session speakers; there were over 240 attendees at the Spring Meeting, so this small survey response limits the conclusions to be drawn. We will keep working to get quality feedback from membership to improve our meeting content because your input truly matters. On a high level, here's how the Spring Meeting scored:





All the educational content sessions (not meals or receptions) had an average score between 3.35 and 4.31. We appreciate the efforts of the WPPA staff, particularly

Jessica Wilson, who helped coordinate all the meeting content and training. We also take to heart your feedback about the event venue services and food as well because those details are an important component of the member experience.

The Dues Committee is one of WPPA's unique committees that comes together every five years to review the dues assessment and make a recommendation to the Trustees for approval. The Chair of the Dues Committee is typically comprised of an Executive Committee member, an Executive Director, a Trustee from Seattle or Tacoma, and other Trustees from various size ports, preferably with budget and finance expertise.

The Association bylaws call for a dues review by the Executive Committee, and a reapproval of the formula by the members, every five years. The dues structure has not been changed since 2007; in 2012 and 2017 the Executive Committee reviewed the dues formula and there was a recommendation to the Trustees that there did not need to be any changes which was approved by the Trustees.

If you are interested in serving on the current Dues Committee, we invite you to apply through your Port Executive Director to **Commissioner Don Meyer by June 3rd**. The Dues Committee will be focused working during the months of June and July to prepare a proposal for the members at the Tuesday Roundtable scheduled for August 2nd. The date for a final vote on the proposal will be set subsequently.
