The Washington Public Ports Association has offered our membership two optional training sessions that can be added to your WPPA Spring Meeting registration. With the release of the <u>Port Governance and Management Guide</u> in 2022, WPPA will we working with our associate members as well as port and association staff to update and align our training modules, resources and other training programs and when appropriate, rethink them. The Real Estate Training Module is one of these updated modules. It will provide attendees with a comprehensive overview of real estate, land use planning, permitting, growth management and financial considerations important to managing your ports portfolio. Fundamentals like balancing your ports mission versus margin and how to build confidence into port decision making when real estate transactions turn complicated. Finally, tips for developing a long-range real estate plan including land banking and how to develop a strategy so that the port has the property to meet its mission well into the future will be discussed.
